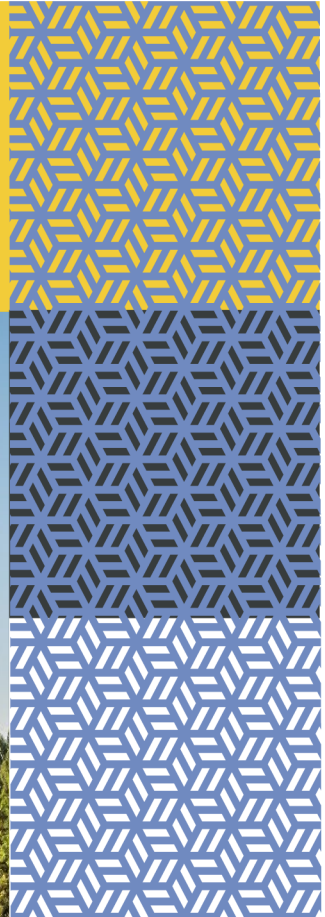

# Fleet Management Training

## Level 3 Transport Managers Certificate of Professional Competence (Road Haulage)

This 10 day course is delivered virtually to maximise training time. The qualification is recognised by the Department of Transport and is for those who need to be named on the Operator Licence as the competent person within road haulage.

The course is run over a period of 4 weeks as small blocks of time allow delegates to fully understand the subjects with time for question practise. Full training notes are provided for the course. The two external exams are sat in our central London office on one day and are managed through the Skills and Education Group awarding body

### The course covers the following topics:

- Civil Law - including company and contract law
- Commercial Law – including business structure and types of shares
- Social Law – including industrial relations, health and safety, drivers hours and licencing
- Fiscal Law – including Tolls, road user levy and vehicle taxation
- Business and Financial management – including marketing, financial management, vehicle costing and insurance
- Access to the market – including Operator Licencing, customs transit systems, and transport documentation
- Technical standards and technical aspects – including maintenance, safe loading, and plating and testing
- Road Safety – including traffic and speed limits, collision procedures, security and congestion charges.

In order to successfully qualify as a Transport Manager both exams must be passed. Either exam can be resat if needed at later exam sittings with additional exam fees required.

## Transport Manager Refresher Training (Road Haulage)

This two day virtual course is designed for those working as Transport Managers, or returning to the industry, who require a refresher to ensure they are fully up to date with legislative changes.

- Drivers Hours including EU, WTD and GB
- Health and safety
